

Commanding Officer's Policy on Preparation

Training & Education, Leader Development, Energy Security, Environmental Management

Marines, Sailors, and Civilians,

My intent is contained in three simple imperatives:

Live Right - Be a Great Teammate - Prepare for the Future

Preparation for the future is a mentality that will drive our actions in all things. Blount Island Command's core mission is to prepare for the future so that the Marine Corps will be ready to respond immediately to a future crisis, anywhere. We are excellent at planning years ahead, understanding that the actions we take today have enduring impact. We must make sure that this mentality is applied universally, in our personal and professional lives, both at home and on mission. When we look back on this season, I want each of us to be able to say that we grew personally and professionally, and we positively influenced our environments. This will not happen without some intention.

Training & Education: We have myriad programs and opportunities to grow and develop, use them! Training is focused on skill acquisition and refinement. Through partnerships with local universities or our own instructors, the business office champions many training opportunities that you can leverage for professional development. Mandatory training classes are important refreshers and will be completed annually. For any who take initiative, there are opportunities every day to cross train with teammates or gain exposure to new parts of our business. Education is also important in that it prepares us for the unknown. Uniformed members will be afforded opportunity to complete their requisite Professional Military Education (PME). Civilian Career Leadership Development (CCLD) and Academic Degree Program (ADP) are competitive education opportunities that will enhance your skills and future career potential. Whether you are in uniform or not, there are Tuition Assistance (TA) programs that can reimburse you for selfeducation at all levels. All personnel should develop Individual Development Plans (IDPs) with their leadership that set goals and identify opportunities for development. Leader Development: MCO 1500.61 mandates that we are engaged in developing Marines and Sailors in all facets of life (Fidelity, Fitness, Family, Future, Finances, Fighter) to prepare them for long term personal and professional success and contribution to society. We owe the same commitment to our civilians. Effective leaders take a holistic approach to developing their team, understanding that only investing in technical or professional competency is short sighted. Through regular interaction and feedback, we will assist and encourage each other in living out our core values and preparing to meet the challenges and opportunities ahead.

Energy Security is a critical area in which we must be working today to prepare for the future. We can anticipate that energy supply could be attacked by an enemy or disrupted by a natural disaster. Marine Corps Support Facility Blount Island (MCSF-BI) must ensure a

secure energy supply and delivery system so that we can continue to execute our mission even in the worst of times. Installation Division has projects in work to improve the *Reliability* of our
